WHEREAS, the City Council finds that the adoption of the City's proposed 2019-2020 fiscal budget as may have been amended is in the best interest of the City;

WHEREAS, the City Council finds that the adoption and levy of a property tax rate of \$.25 per \$100 valuation for the fiscal year 2019-2020 is necessary for the payment of the City's expenditures and in the best interest City; and,

WHEREAS, the City Council desires continued public input from Citizens on the fiscal year 2019-2020 proposed budget;



BE IT FINALLY RESOLVED that to the Mayor and City Attorney are hereby directed to prepare the necessary ordinances to adopt the 2019-2020 City Budget and adopt and levy a property tax rate of \$.25 per \$100 valuation.

ORDINANCE 09032019-1

WHEREAS, the City of Golinda is required to have a tax assessor-collector;

WHEREAS, the McLennan County Tax Assessor-Collector has agreed to serve as the Tax Assessor-Collector for the City of Golinda;

WHEREAS, Texas Law authorizes the City of Golinda and McLennan County to enter into an interlocal agreement providing that the McLennan County Tax Assessor-Collector to assess and collect the City taxes on behalf of the City of Golinda; and,

WHEREAS, McLennan County has provided an Interlocal Agreement for ad valorem tax collection services which is attached hereto and that is utilized by the political entities of McLennan County to contract with the McLennan County Tax Assessor-Collector;

WHEREAS, the Golinda City Council finds that entering into an agreement with McLennan County for ad valorem tax collection services is in the best interest of the City.

THEREFORE, BE IT ORDAINED that the Interlocal Agreement for ad valorem tax collection services presented by McLennan County should be and is hereby approved.

BE IT FURTHER ORDAINED that the Mayor of the City of Golinda is hereby authorized to execute said interlocal agreement and any ancillary documents necessary to accomplish said interlocal agreement.


BE IT FURTHER ORDAINED that the City Attorney is authorized and directed to negotiate and represent the City in accomplishing this agreement with McLennan County.
