

ORDINANCE NO. 21-0907-2

2021-2022 PROPERTY TAX RATE ADOPTION ORDINANCE

WHEREAS, the City of Golinda, Texas as a Type A General Law City has the authority under Section 51.012 of the Texas Local Government Code to adopt ordinances, not inconsistent with state law, that is necessary for the government, interest, welfare, or good order of the municipality as a body politic;

WHEREAS, the City Council finds it necessary for the government, interest, welfare, and good order of the municipality as a body politic to adopt the filed proposed 2021-2022 budget;

WHEREAS, the City Council finds the 2021-2022 City Budget requires the levy and collection of a property tax in the amount of \$0.239524 per \$100 valuation on all property within the City as allowed by law;

WHEREAS, the City Council finds that the requirements of State law to levy and collect a property tax for the 2021-2022 fiscal year have been met including the posting of notice and the holding of a public hearing; and,

WHEREAS, THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

WHEREAS, THE TAX RATE WILL EFFECTIVELY BE RAISED BY (8.31) PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$3.00. WHICH IS A TOTAL TAX AMOUNT OF \$239.52.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GOLINDA, TEXAS:

SECTION 1: That there shall be, and is hereby, levied and collected and a property tax at a rate of \$.0.239524 per \$100.00 assessed valuation upon all taxable real and personal property within the corporate limits of the city that is subject to taxation for the year 2021.

Each one-hundred-dollar valuation, to wit:

For the purposes of maintenance and operations	0.239524
For the payment of principal and interest on the debt of this City	.0000

SECTION 2: That all receipts appropriated by this Ordinance are hereby made to the above funds.

SECTION 3: That all 2021 ad valorem taxes shall be paid before February 1, 2022, and taxes not paid by that time shall be increased by such penalty and interest as provided by law.




SECTION 4: That this Ordinance shall be in full force and effective immediately upon passage by the City Council.


SECTION 5: That it is hereby officially found and determined that the meeting at which this Ordinance is passed was noticed and has been open to the public as required by law.


